Continuation of Achievements -

There was a dramatic increase in pass sales and an increase in attendance in the 2014 festival. Film attendance was up by approximately 4.5%, when compared to 2013. A record 48 filmmakers and industry personnel attended during festival week, resulting in over 60 flight segments and more than 200 room nights booked in local hotels and vacation rentals. Eighty-seven percent of attendee survey respondents hailed from the Four Corners area, including Bayfield, Pagosa Springs, Flagstaff, Farmington, Sandia Park, Rio Rancho and Albuquerque, and Las Vegas. We are experiencing a higher volume of visitors coming from the Albuquerque area because DF is reaching out to that market. DF's school program is free to invited students, screening movies selected by a committee of educators with strong film backgrounds. We seek to improve the students' capacity to judge media messages using highly creative films full of new ideas and unique viewpoints that lend themselves to engaging and intriguing discussion. In 2014 the program reached 611 students and 44 teachers in Durango and Ignacio, ranging from elementary to middle school-aged children. Next year Durango Film's program of independent film for students and teachers will be called the Reel Learning Program. When asked if s/he had learned anything in the program, one Middle School student wrote, "I can make a film to inspire other people just like these films did." Achievements, Continued -

DF partnered with the Santa Fe University of Art & Design to present a free student workshop in which they brought their flagship "A Camera in Every Hand" program directly to the Durango film community.

Durango Film is striving to grow the impact of the film festival and become one of the premier film festivals in the United States.
