Learning school program, totaling 7,338 attending festival programs. We screened a total

of 115 films in the 5-day festival. Filmmakers making the journey to Durango tell us how

much they appreciate Durango audiences, who go out of the way to make them feel welcome.

This year 48 filmmakers plus their guests were able to attend the festival. This figure is

down from the previous year, due to a large number (54) of foreign films being screened.
